Annual Report for FY'08
(NRS 616C.295)

In FY08, 86 Insurers and/or Third Party Administrators appear before the Hearing and Appeals Officers in 16,822 cases. In FY 2008 the Hearing and Appeals Officers rendered decisions involving 64 insurers/TPAs in 16,087 cases.

The Appeals Officer's heard disputes from 59 Insurers/Third Party Administrators totaling in 3,696 cases. They rendered a decision (either affirming, reversing or remanding) in 36% of their cases while 64% were closed by withdrawals, dismissals, etc.

The Hearing Officer's heard disputes from 61 Insurers/Third Party Administrators in 12,391 closed cases. They rendered decisions in 55% of the cases, while 45% were settled.

The attached is a summary of ALL the Insurer/Third-Party Administrator by disposition (affirmed, reversed, remanded and resolved) and each disposition by the type of benefits denied before the Hearing and Appeals Office. The following lists are a breakdown of the same data by each Insurer/Third-Party Administrator.
