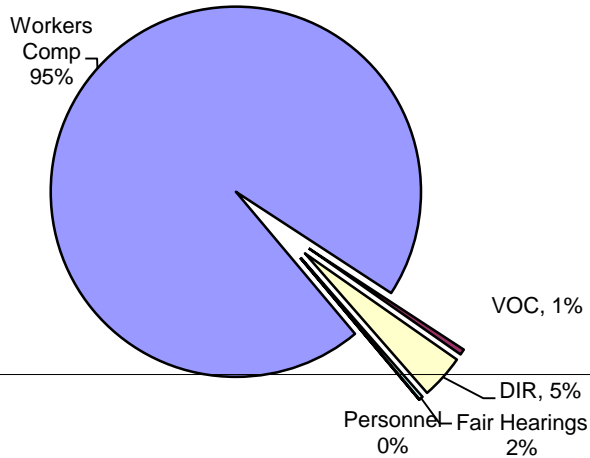

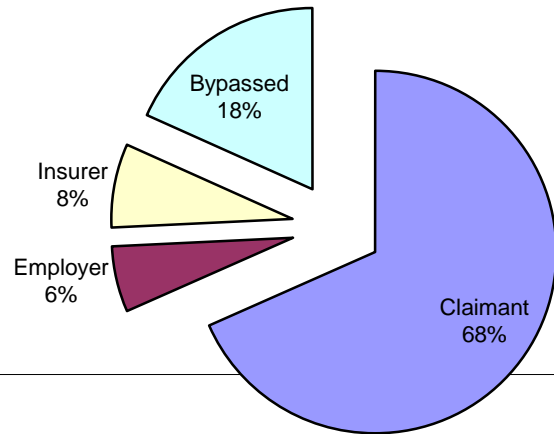

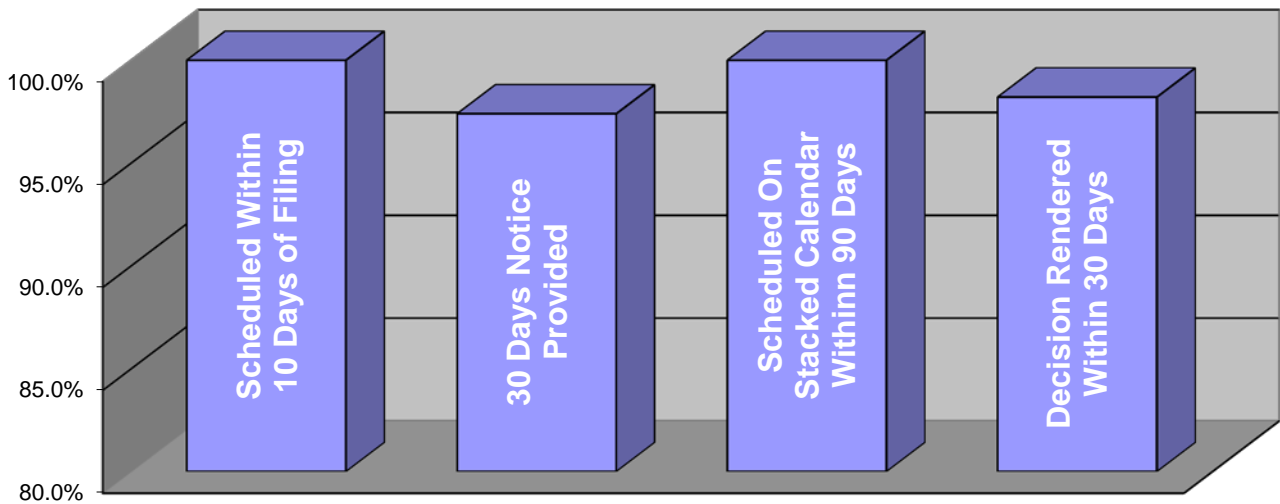

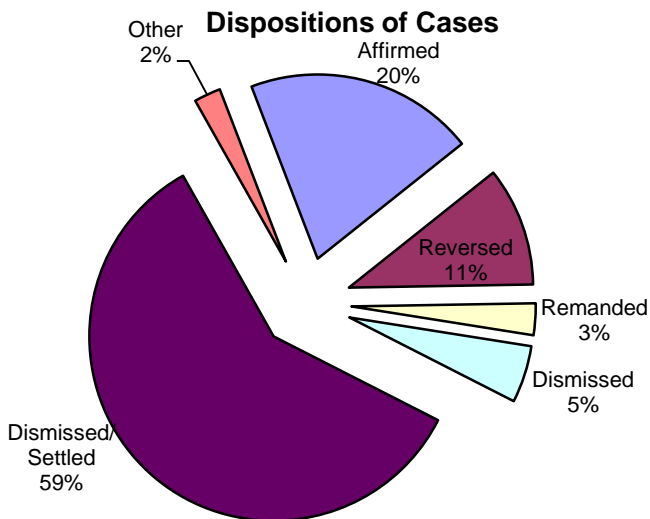

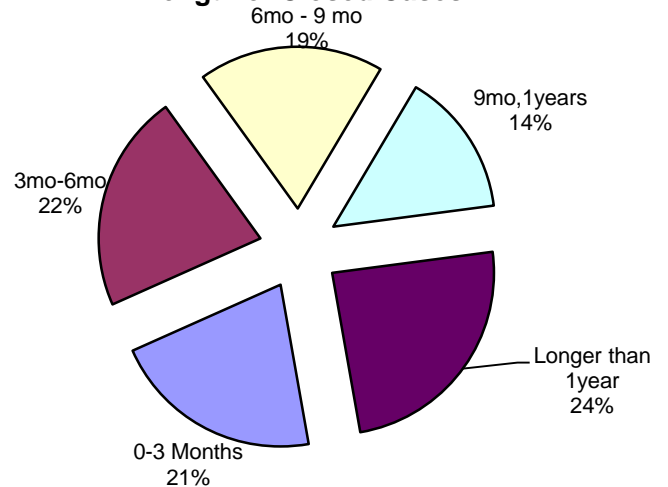

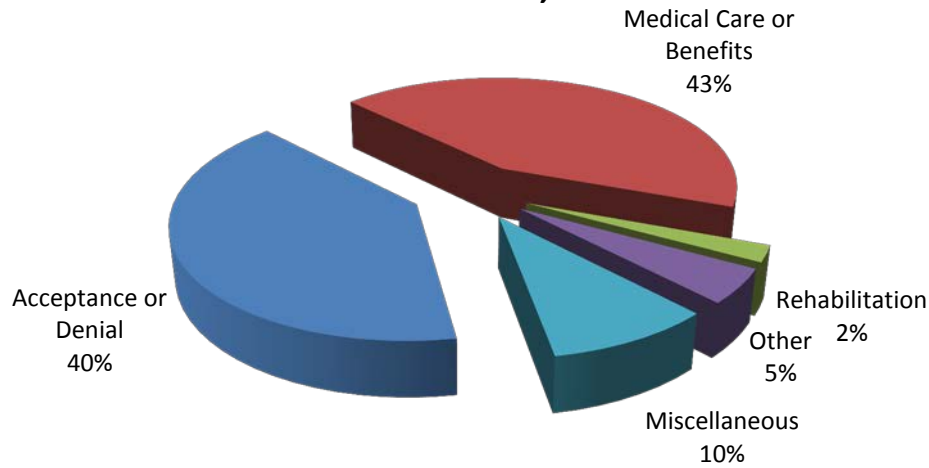

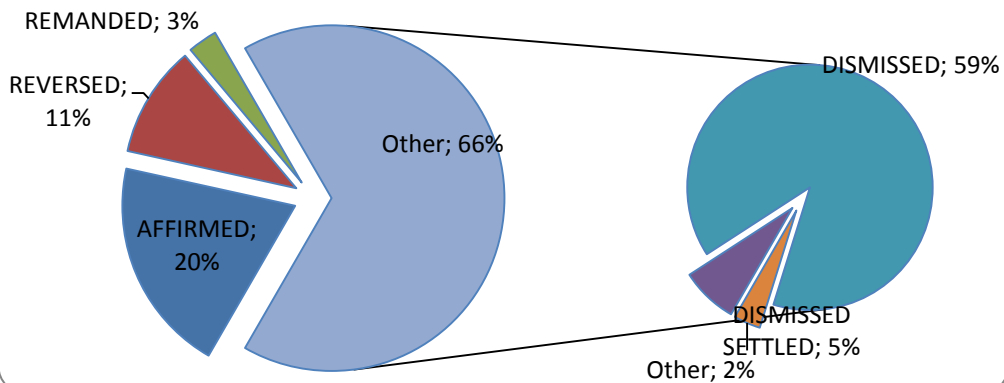

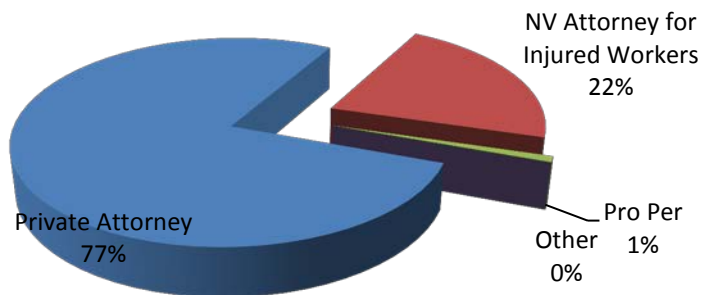
Before The Appeals Officer Issue of Cases, FY16



Before The Appeals Officer Disposition of Cases, FY16



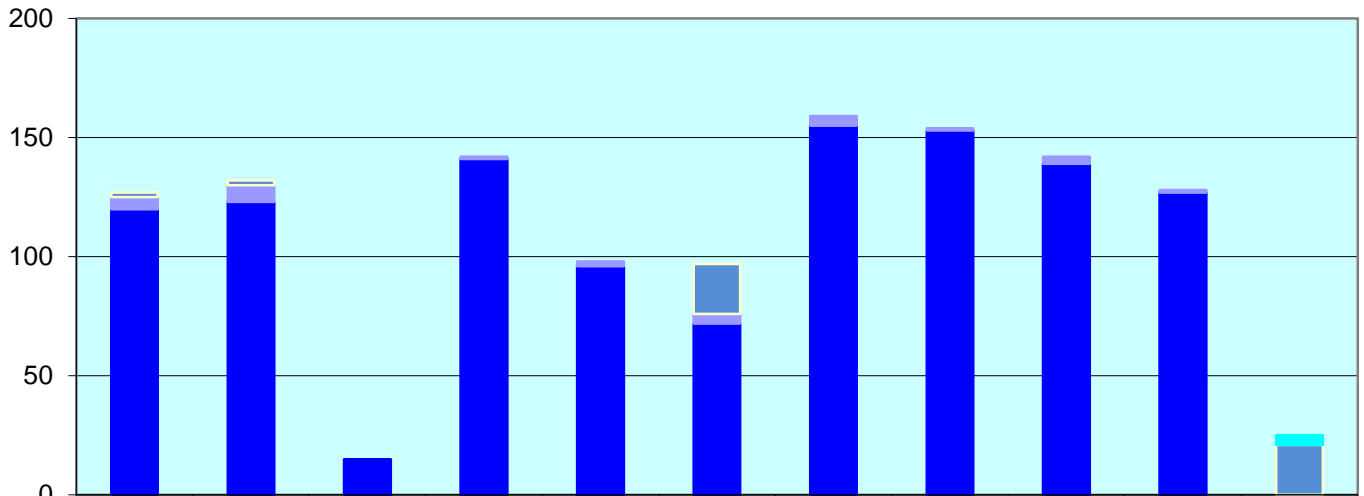
Before The Appeals Officer, FY16 Representation of the Injured Worker

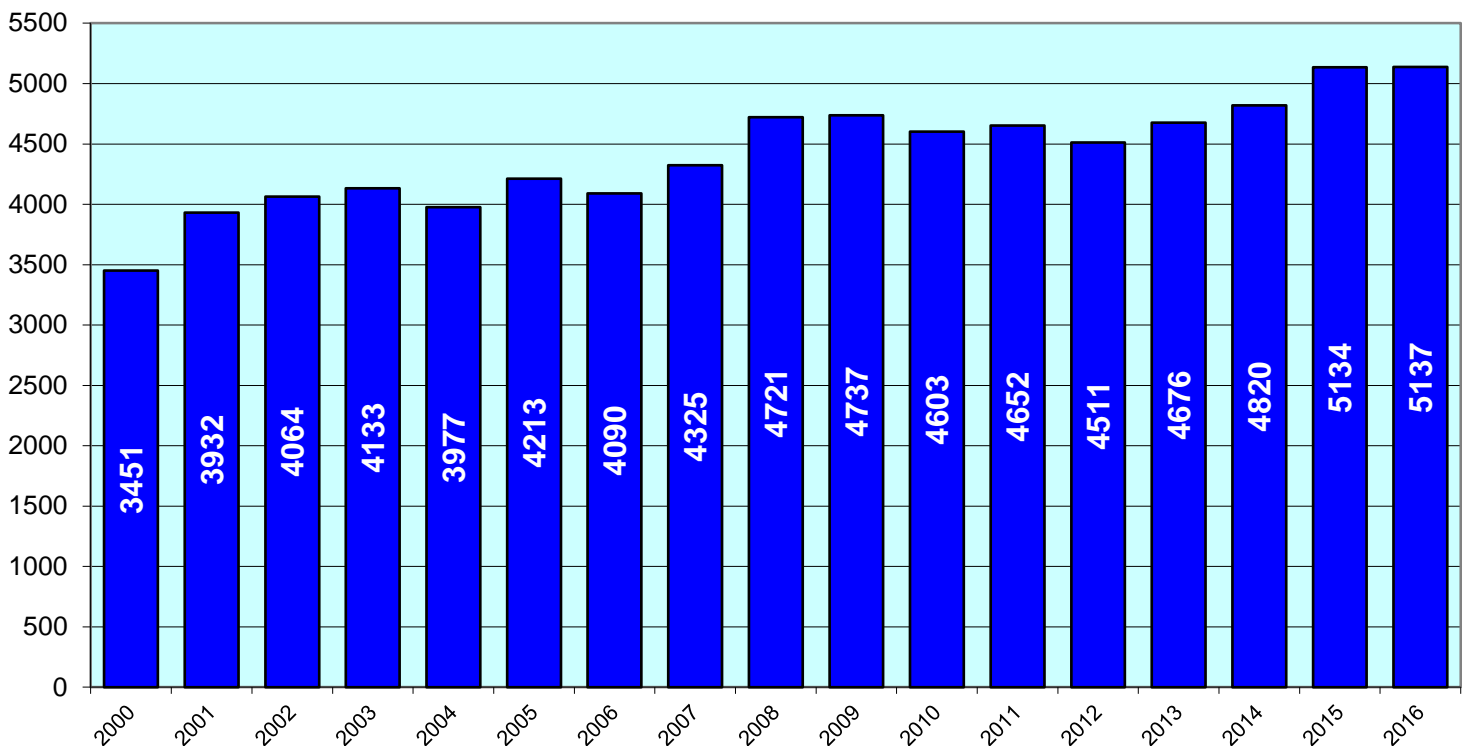

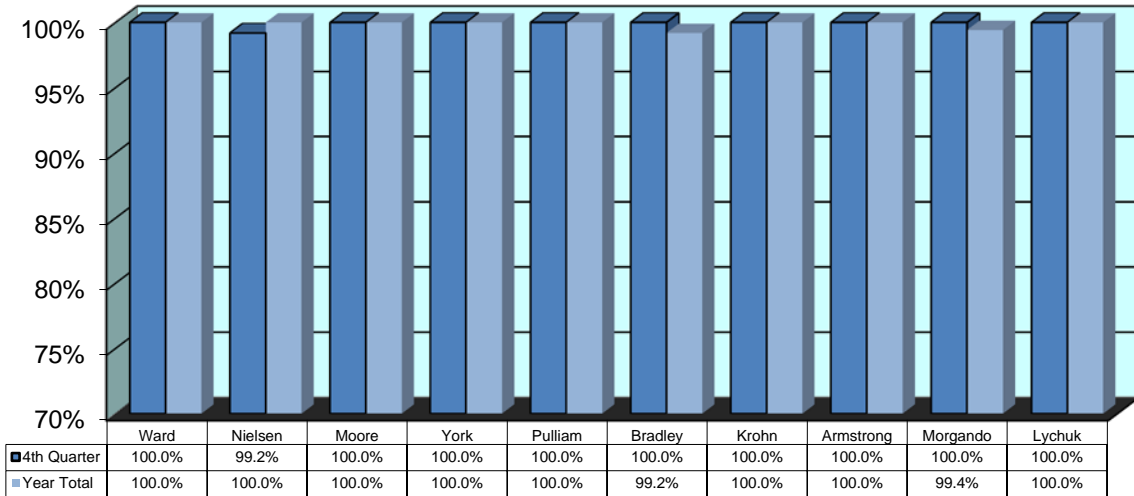

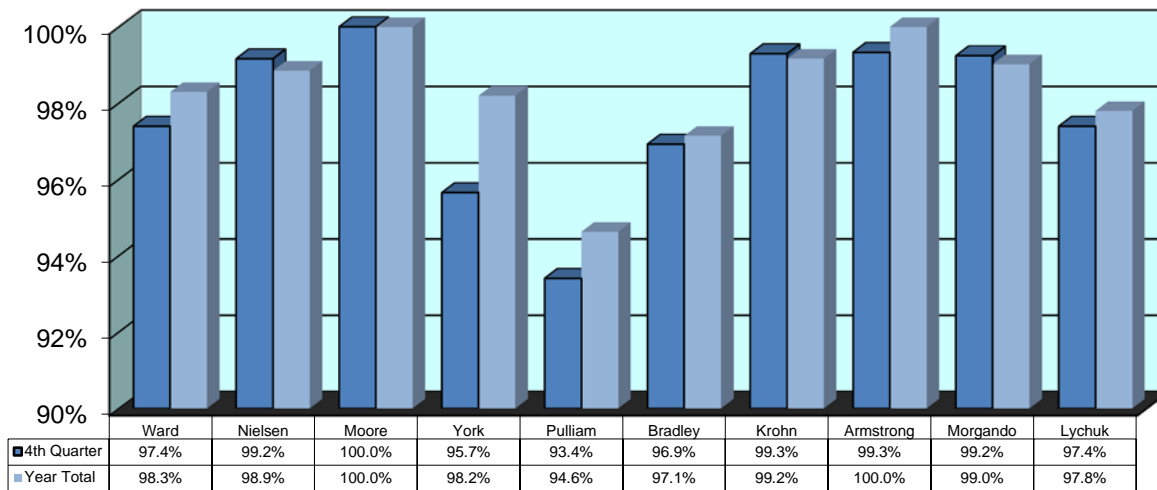

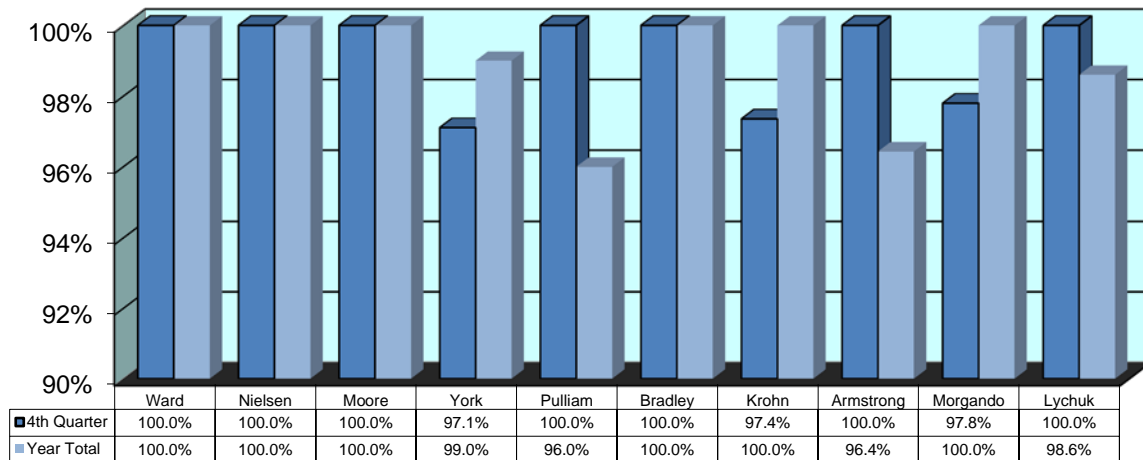

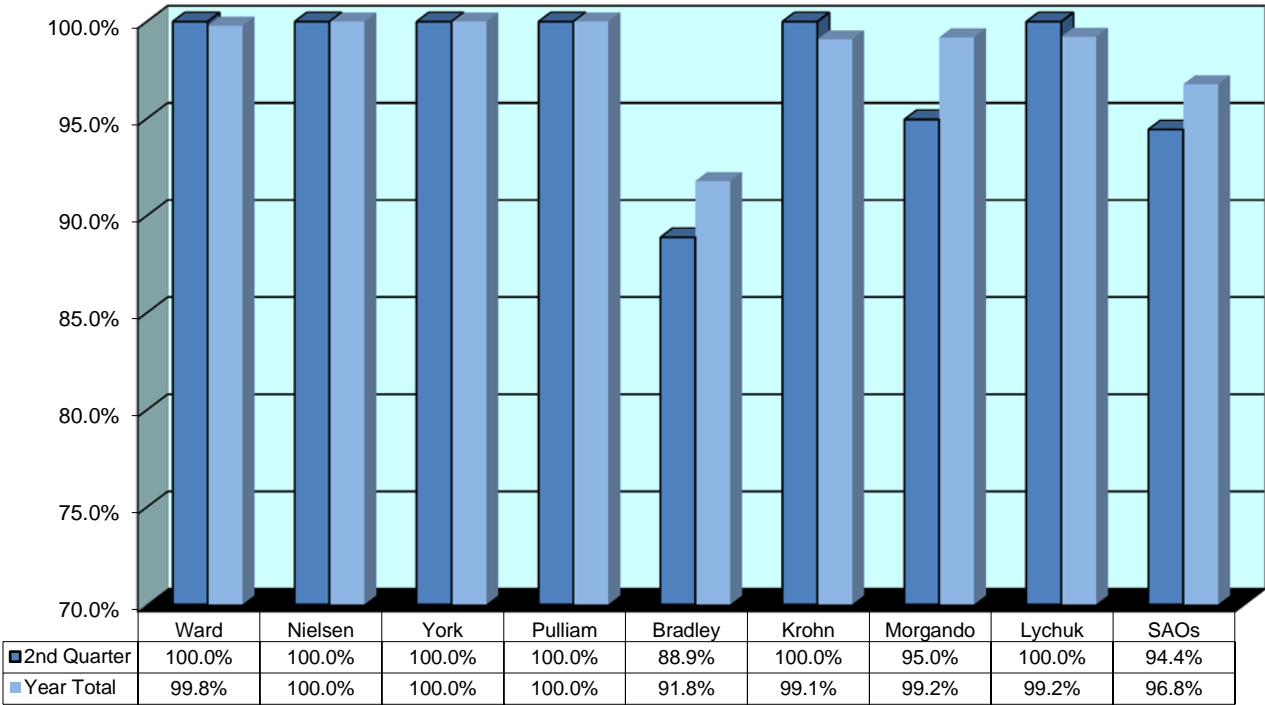

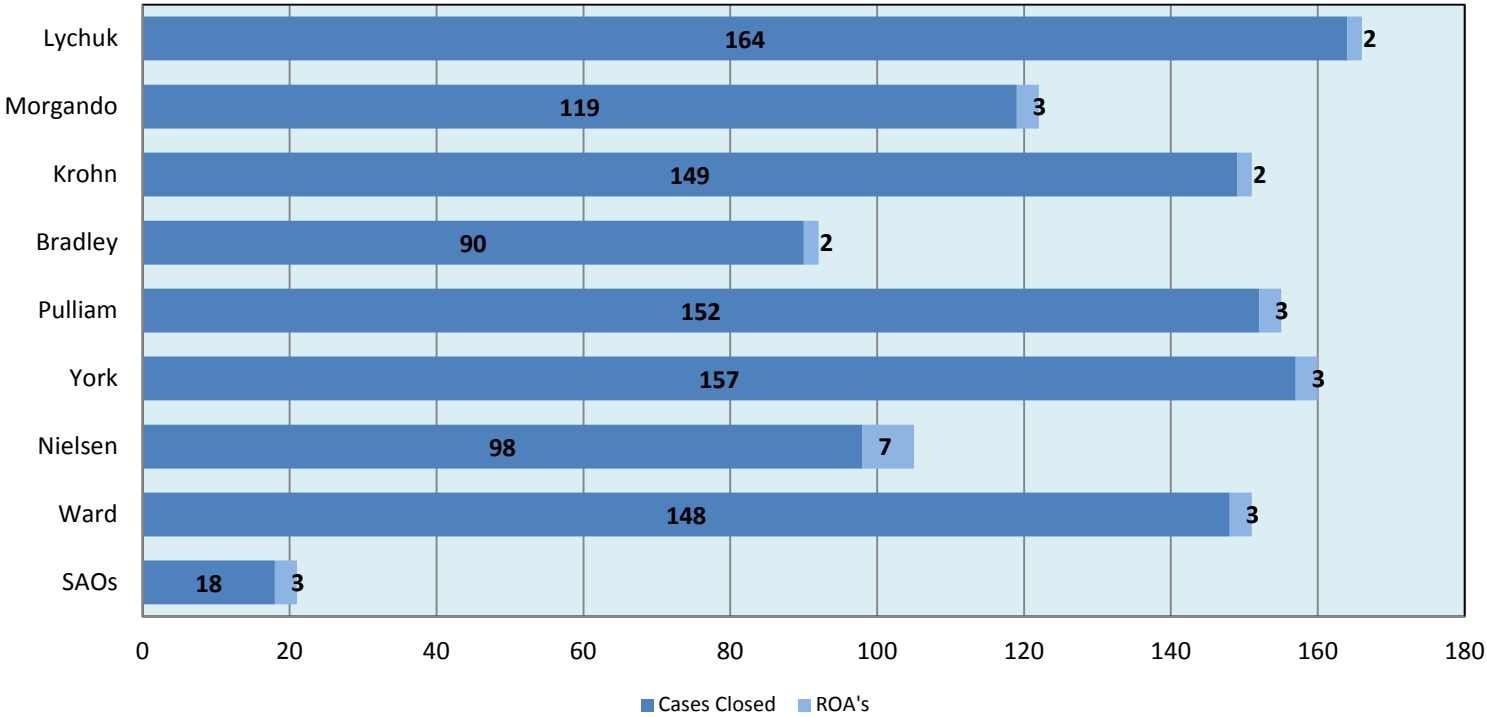

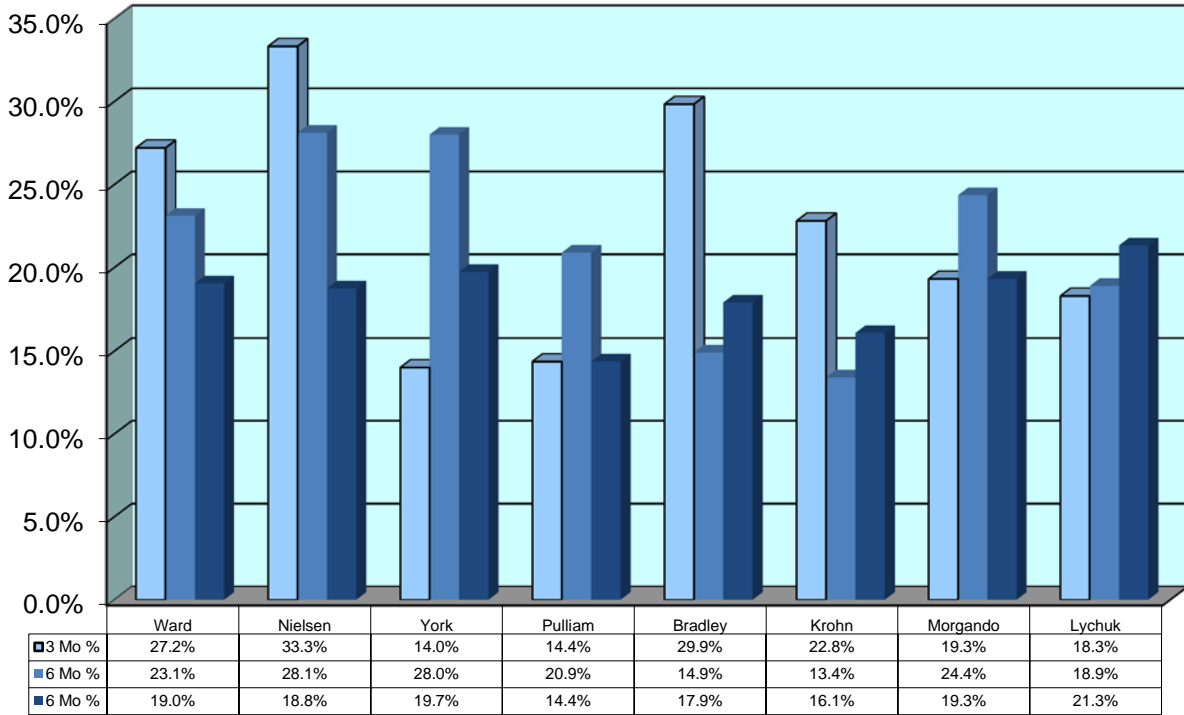
Cases Resolved vs. Appealed to District Court



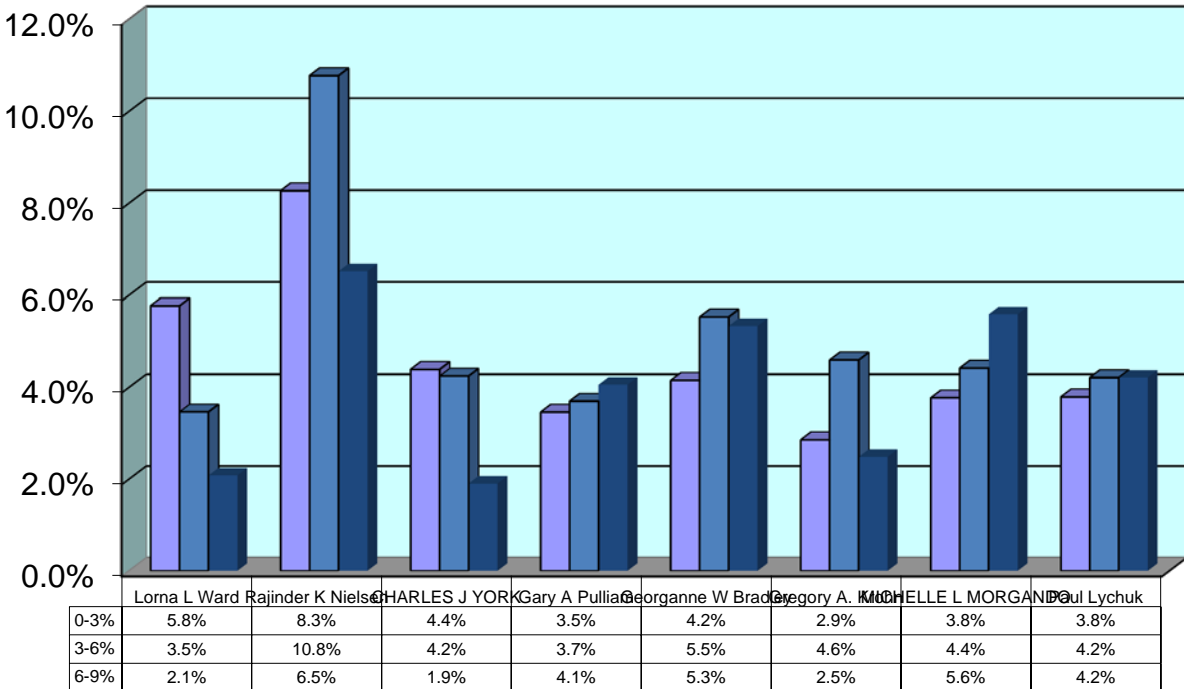
